



CIRCULAR TO DEPARTMENTS AND AUTHORITIES NO. 4 of 2010

UPDATED ADMINISTRATIVE ADJUSTMENT OF DISTRICT ALLOWANCES

This Circular replaces Circular No. 3 of 2006, Circular No. 1 of 2008, Circular No. 8 of 2008, and Circular No. 1 of 2010.

An error was made in the calculation of the annual District Allowance rate for Fitzroy Crossing as shown in Circular No. 1 of 2010. A higher rate was stated that would result in a \$40 per annum overpayment. The correct annual District Allowance rate for Fitzroy Crossing is attached.

The Circular shows rates based on an administrative increase approved by Government to the District Allowance provided for in the District Allowance (Government Officers) General Agreement 2005 and the District Allowance (Government Wages Employees) General Agreement 2005.

The District Allowance rates have been administratively increased by 2.2% with effect from the beginning of the first pay period on or after 1 July 2009.

The administrative increase also applies to those employees in receipt of District Allowance not covered by the District Allowance General Agreements.

The administrative adjustment is in accordance with the official Consumer Price Index for Perth as published by the Australian Bureau of Statistics for the preceding 12 months to the end of the March quarter 2009.

Negotiations will occur to replace the District Allowance (Government Officers) General Agreement 2005 and the District Allowance (Government Wages Employees) General Agreement 2005. It is intended that the outcome of the negotiations will absorb this administrative increase.
