This form is to be used by plumbing contractors applying to amend the types of work they are authorised to undertake. There is no fee payable when lodging this form.

In Western Australia the Plumbers Licensing and Plumbing Standards Regulations 2000 authorises the holder of a contractor's licence to undertake the following types of work:

- water supply plumbing work, sanitary plumbing work and drainage plumbing work;
- water supply plumbing work and sanitary plumbing work;
- water supply plumbing work and drainage plumbing work;
- water supply plumbing work;
- drainage plumbing work; or
- sanitary plumbing work and drainage plumbing work.
