CPD reminder – 2013 Program now underway

Welcome to the Settlement CPD Program for 2013

Compulsory Professional Development (CPD) is a requirement for all licensed settlement agents. Failure to complete your CPD requirements may result in your triennial certificate not being renewed.

In each calendar year, participants must obtain a total of six points of CPD approved activities. Of these six points, at least four points are to be earned from the core activities and the remaining two points from either core or elective CPD activities.

Don't put your licence or registration at risk in 2013!

The Australian Institute of Conveyancers (AICWA) has been contracted by Consumer Protection to provide CPD activities in 2013. The first sessions for 2013 have already commenced, however the take-up at this time has been low.

Agents are encouraged to complete their CPD training early as sessions are already booking out and lack of course availability will not be accepted as a valid reason for not complying.

Notes:

- Each topic in the program is worth 2 CPD points. Settlement agents require 4 Core points and 2 Elective CPD points per annum.
- **Australian Consumer Law and Landgate Practices and Procedures are mandatory core topics and are marked with a (C). The electives are marked with an (E).**
- Venues may vary depending upon availability and the number of attendees to each session.
- Session times are session 1 – 9:30am to 11:30am, session 2 – 12:15pm to 2:15pm, session 3 – 2:30pm to 4:30pm.
- Evening sessions run from 5:30pm to 7:30pm.
- Attendees must be present for the full two-hour session to attain the 2 CPD points.
- Transport, parking and lunch are the attendee's responsibility.
