NOLS

- NOLS –not apply if occupation not currently licensed in a State or Territory.
- The first wave of NOLS is planned to commence in September 2013 in WA.
- NOLS relates to *licensing only* and does not cover technical compliance.



Legislation Legislation

- General regulations will cover:
 - > Fees
 - > Appeals/reviews
 - > Offences
 - **Eligibility**
- Specific occupation regulations will apply to each specific occupation and cover:
 - > Qualifications to obtain the licence.
 - Scope of work or what is covered by the licence type.



Administration & RTOs

- Qualification for NOLS licence to be based on National Competency training packages.
- Training delivered by Registered Training Organisations.
- Each State will continue to issue licences.
- Fees will be set by each State or Territory.
- To be licensed in State of Residence.



Gas fitting in WA

- NOLS will not cover all GF work in WA.
- NOLS to cover our current:
- Class G and
- > Some areas of our Class I (Industrial) GF



Gas fitting in WA

NOLS will not cover

- Class E Gas Fitter
- Class P Gas Fitter and
- Some areas of our Class I (Industrial)
- Authorisations
- Apprentices not licensed under NOLS





Class I Gas fitting covered by NOLS

Type B Scope

Type B gas appliance

- Appliance more than 10MJ/hr & <5,000MJ/hr
- Water heater / space heater / vat or tank heater
- Dryer or oven not associated with volatile solvents or hazardous atmospheres
- Batch kiln with flame supervision & safeguards
- Cooking appliance / furnace / stationery engine
- OR







Class I Gas fitting covered by NOLS

Type B Scope (continued)

- Gas Appliance more than 10MJ/hr and
 - < 10,000MJ/hr
- Steam Boiler
- Thermal fluid heater
- Does not include a mobile engine
- Does not cover Authorisations



WA Gas Fitters

- Current licences not covered by NOLS to remain licensed by local jurisdiction.
- Unrestricted Class G GF will map directly across to a NOLS licence.
- Some Class I GFs will also map across to NOLS.
- Some up skilling may be required to meet the NOLS requirements.



Summary

- NOLS planned for WA September 2013.
- WA Class G & some Class I GF map to NOLS.
- Other currently licensed GF to remain locally licensed.
- NOLS does not cover technical compliance.
- Basic principle you can do tomorrow what you can do today.

Three Tier Option

3 levels of licence

- Contractor
- Full licensee (Cert IV)
- Supervised licensee



Three Tier Option

2 Sub Options

- Sub Option 1
 - > Increase competency req for full licence.
 - ➤ Additional Cert IV units required.
 - ➤ IAC preferred option.



Three Tier Option

Sub Option 2

- > Competency requirements broadly in line with current req.
- > Consistent across jurisdictions.
- > Smaller no. of Cert IV units full licence.



Two Tier Model

- Contractor Licence
- Full Licensee
 - > Removes supervised licensee level.
 - > Complete Cert III level qualification.
 - > Conduct all regulated work for licence category
 - > Certifying work as compliant.
 - Removes need for contractors to complete advanced business competencies.





Automatic Mutual Recognition

"Driver's licence" model

- Current State/Territory licences recognised by another jurisdiction.
- No need apply for another licence or
- Pay additional licence fee.
- Achieves labour mobility with lower costs.
- Option not fully developed or costed.



RIS Feedback

RIS Feedback being sought on:

- Scope & scale of proposed changes.
- Impact on licensees & businesses.
- Durability of reforms.
- Merits of reform under different models.
- Impact on costs & safety outcomes.
