Statutory Review of the Residential Parks (Long-Stay Tenants) Act 2006

Thank you for contacting the Regulatory Gatekeeping Unit regarding further amendments to the recommendations contained in the Decision Regulatory Impact Statement previously approved on 12 June 2015.
